While Prairie Mines & Royalty ULC (PMRU) provides the initial payment, under the coal contracts SaskPower is ultimately liable for these amounts. While reimbursable payments of \$27,920,000 were paid to PMRU for royalties in the 2017-18 year, \$990,000 was refunded thereafter related to prior years. Monies are then remitted to the Saskatchewan Department - Ministry of Energy and Resources.</p> <p>Amended July 2019 to consolidate payments to the level of one ultimate Payee (e.g. the Government of Saskatchewan).</p>
