

# CUSTOMER-OWNED TRANSFORMATION RATES

## STANDARD RATE

This rate is for metered non-residential and non-farm loads greater than 75 kilovolt amperes (kVA) and up to and including 3,000 kVA, served through customer-owned transformation and to which no other rates apply.

## MINIMUM BILL

The basic monthly charge plus \$4.869/kVA of the maximum demand registered in the defined billing periods between May 1st to October 31st and November 1st to April 30th. The month containing the highest registered demand within a defined billing period will be used to calculate the minimum bill for the remainder of that period.

## LOADS UP TO 75 AND OVER 3,000 KVA

- For loads up to 75 kVA refer to **Customer-Owned Transformation — Small Commercial Rates**.
- For loads over 3,000 kVA refer to **Customer-Owned Transformation — Power Standard Rates**.

# CUSTOMER-OWNED TRANSFORMATION RATES

## RECORDED DEMAND

- The maximum kVA demand registered during the current month, **OR**
- For services with approved time-of-day metering, the greater of the maximum kVA demand registered between the hours of 07:00 to 22:00, Monday through Friday, excluding statutory holidays **OR** 85 per cent of the maximum kVA demand registered at any other time during the current month.

## AVAILABILITY

E10 and E12 rates are closed to new customers.

# CUSTOMER-OWNED TRANSFORMATION RATES

## SMALL COMMERCIAL RATE

This rate is for metered commercial and municipal loads up to and including 75 kilovolt amperes (kVA) served through customer-owned transformation and to which no other rates apply.

## MINIMUM BILL

The basic monthly charge plus \$4.869/kVA of the maximum demand over 50 kVA registered in the defined billing periods between May 1st to October 31st and November 1st to April 30th. The month containing the highest registered demand within a defined billing period will be used to calculate the minimum bill for the remainder of that period.

## LOADS OVER 75 KVA

For loads over 75 kVA refer to **Customer-Owned Transformation — Standard Rates**.

## RECORDED DEMAND

- The maximum kVA demand registered during the current month, **OR**

## CUSTOMER-OWNED TRANSFORMATION RATES

- For services with approved time-of-day metering, the greater of the maximum kVA demand registered between the hours of 07:00 to 22:00, Monday through Friday, excluding statutory holidays **OR** 85 per cent of the maximum kVA demand registered at any other time during the current month.

# CUSTOMER-OWNED TRANSFORMATION RATES

## POWER TIME-OF-USE RATE

This rate is for large commercial, farm, and industrial loads served through customer-owned transformation as an alternative to **SaskPower Supplied Transformation — Standard Rates** and **Customer-Owned Transformation — Power Standard Rates**.

## MINIMUM BILL

The basic monthly charge plus the demand charge.

## RECORDED DEMAND

The monthly recorded demand is the maximum kVA demand registered during the current month.

# CUSTOMER-OWNED TRANSFORMATION RATES

## **BILLING DEMAND**

The monthly billing demand is the monthly recorded demand, but the billing demand shall not be less than 75 per cent of the maximum billing demand in the preceding 11 months.

## **ON-PEAK ENERGY CONSUMPTION**

The monthly energy consumed between the hours of 7:00 to 22:00, Monday through Friday, excluding statutory holidays.

## **OFF-PEAK ENERGY CONSUMPTION**

The monthly energy consumed in all hours except for the on-peak hours.

## **AVAILABILITY**

These time-of-use rates are optional — at the customer's request. Once a customer requests to change to these rates they must stay on for at least one year.

## POWER STANDARD RATE

This rate is for large commercial and industrial loads served through customer-owned transformation as an alternative to **SaskPower Supplied Transformation — Standard Rates**.

## MINIMUM BILL

The basic monthly charge plus the demand charge.

## RECORDED DEMAND

The monthly recorded demand is the maximum kVA demand registered during the current month.

## BILLING DEMAND

The monthly billing demand is the monthly recorded demand, but the billing demand shall not be less than 75 per cent of the maximum billing demand in the preceding 11 months.

# CUSTOMER-OWNED TRANSFORMATION RATES

## POWER STANDARD RATE – CAPACITY RESERVATION SERVICE

This rate applies to Power Class customers requiring capacity reservation who are served through customer-owned transformation and self-generating a portion of their power requirements using non-renewable sources. Customers installing renewable self-generation are eligible to remain on their current published rate.

**Self-Generation Sources:** Renewable self-generation sources include solar, wind, flare gas, biomass, geothermal and hydropower generation. All other sources are considered non-renewable.

**Reservation Capacity:** The customer must nominate in writing the reservation capacity in kVA to be provided by SaskPower. The nomination shall provide details of how the Reservation Capacity was determined.

SaskPower provides no guarantee that any loads taken in excess of the customer's reservation capacity will be available. SaskPower may install protective equipment to limit the customer to their nominated capacity if it believes those facilities to be at risk due to load uptakes in excess of their nominated capacity.

The customer may submit a written request to **increase** the Reservation Capacity at any time. All requests for capacity increases will follow SaskPower's regular load interconnection process. 12 months after the original nomination of Reservation Capacity or 12 months after any subsequent change to the Reservation Capacity, the customer may submit a written request to **reduce** the Reservation Capacity. Every request to change the Reservation Capacity should include details of how the new Reservation capacity was determined.

# CUSTOMER-OWNED TRANSFORMATION RATES

## **MINIMUM BILL**

The basic monthly charge plus the demand charge.

## **RECORDED DEMAND**

The monthly recorded demand is the maximum kVA demand registered during the current month.

## **BILLING DEMAND**

The monthly billing demand shall be the greater of the monthly Recorded Demand or the Reservation Capacity, but shall not be less than the maximum demand registered in the preceding 23 months.
