- 3. **Product Installation.** The Landlord permits SaskPower's contractors (each, a "Contractor") to conduct a free home evaluation and install free basic energy-efficient products.
- 4. **Site Visits.** The Landlord permits SaskPower to conduct site visits to verify compliance, eligibility and installation/operation of energy efficiency measures.
- 5. **Program changes.** SaskPower may, without any penalty or obligation, in its sole discretion, at any time, modify any term(s) or condition(s) in this Landlord Consent Form or any of its requirement(s) for eligibility or Program criteria, and modify or terminate any of its program(s), including, without limitation, the Program.
- 6. **Availability of funding.** Funding may be limited. SaskPower, in its sole discretion, may prioritize applications and decide funding, if any, a property may receive.
