

SASKPOWER-SUPPLIED TRANSFORMATION RATES

STANDARD RATE

This rate is for metered non-residential and non-farm loads greater than 75 kilovolt amperes (kVA) and up to and including 3,000 kVA, served through SaskPower-supplied transformation and to which no other rates apply.

MINIMUM BILL

The basic monthly charge plus \$4.869/kVA of the maximum recorded demand over 50 kilovolt ampere (kVA) registered over the past 11 months.

LOADS UP TO 75 AND OVER 3,000 KILOVOLT AMPERES (kVA)

- For loads up to 75 kVA refer to Customer-Owned Transformation — Small Commercial Rates.
- For loads over 3,000 kVA refer to Customer-Owned Transformation — Power Standard Rates.

RECORDED DEMAND

- The maximum kVA demand registered during the current month, *or*
- For services with approved time-of-day metering, the greater of the maximum kVA demand registered between the hours of 07:00 to 22:00 Monday through Friday, excluding statutory holidays or 85 per cent of the maximum kVA demand registered at any other time during the current month.

SASKPOWER-SUPPLIED TRANSFORMATION RATES

SMALL COMMERCIAL RATE

This rate is for metered commercial and municipal loads up to and including 75 kilovolt amperes (kVA) served through SaskPower-supplied transformation and to which no other rates apply.

MINIMUM BILL

The basic monthly charge plus \$4.869/kVA of the maximum recorded demand over 50 kilovolt ampere (kVA) registered over the past 11 months.

RECORDED DEMAND

- The maximum kVA demand registered during the current month, *or*
- For services with approved time-of-day metering, the greater of the maximum kVA demand registered between the hours of 07:00 to 22:00 Monday through Friday, excluding statutory holidays or 85 per cent of the maximum kVA demand registered at any other time during the current month.

SASKPOWER-SUPPLIED TRANSFORMATION RATES

NON-FARM IRRIGATION RATE

This rate is for non-farm irrigation loads served through SaskPower-supplied transformation for the annual pumping season between April 1 and Oct. 31.

MINIMUM BILL

The basic seasonal charge plus the demand charge.

OVER 1,000 KILOVOLT AMPERES (kVA)

For loads in excess of 1,000 kVA, a different rate structure will apply. Please see SaskPower Supplied Transformation — Standard Rates, Customer-Owned Transformation — Standard Rates or Customer-Owned Transformation — Power Standard Rates.

UNMETERED GENERAL SERVICE RATE

This rate is for unmetered miscellaneous loads where the electrical consumption is constant or predictable.

Examples of this type of load include: Rest room lighting; telephone booths; school warning lights; decorative lighting; automatic railroad crossing protection; and traffic lights.

UNMETERED CATV POWER RATE

This rate is for power supply units used for cable television.

This rate is for cable television rectifiers.

UNMETERED X-RAY RATE

This rate is for X-rays of three kilovolt ampere (kVA) capacity or larger where dedicated transformer capacity and service entrance is provided.
