General

- Saskatchewan Power Corporation (the "Contest Sponsor") is sponsoring the SASKPOWER MySaskPower Signup for Smart Meter Recipients Contest (the "Contest"). The Contest will commence on May 1, 2021 until July 31, 2021 at 11:59 PM CST (the "Contest Period").
- 2. By entering this Contest, the entrants agree to accept and abide by these rules and regulations (the "Contest Rules"). All decisions of the Contest Sponsor with respect to any aspect of this Contest, including without limitation the eligibility of entries and prize awards, are final and binding on all entrants in all matters as they relate to this Contest.

Eligibility

- 3. Participation in the Contest is limited to SaskPower customers who have (a) signed up for a residential smart meter and (b) signed up for a MySaskPower account. Employees of SaskPower (including active and inactive, temporary, permanent, full-time and part-time employees) are ineligible to participate in this contest. To be eligible to sign up for a residential smart meter, the SaskPower customer must reside in a detached private residence (their "Residence"); SaskPower customers who reside in multi-unit dwellings are not eligible to enter the Contest. SaskPower customers who are unable to provide consent to the installation of a smart meter at their residence may enter the Contest by using the Write-in Entry option described in subsection 5(4) of these rules and regulations. The Contest is void outside the province of Saskatchewan.
- 4. By entering the Contest, a winner consents to the use of their likeness/image, name and city/town of residence without compensation other than the prize awarded in any publicity or advertising carried out in connection with the Contest in any medium worldwide by the Contest Sponsor and/or its advertising or promotional agencies without limitation or further notification.

How to Enter

5. The Contest can be entered by *one* of the following four methods:

1) Method One:

- a) by signing up for the installation of a smart meter at your Residence through the online form supplied by SaskPower or by calling SaskPower at 1-888-SKPOWER, during the Contest period (signing up for a smart meter requires that you provide the full address of your Residence and a confirmation that the Residence is a detached home, and that you agree to the installation of a smart meter at your Residence on SaskPower's terms and conditions for such installation, which can be found at the following link: <u>Installing Your</u> <u>Smart Meter – What to Expect (saskpower.com)</u>; and
- b) by signing up for a MySaskPower Account during the Contest period.

2) Method Two:

- a) by having signed up for the installation of a smart meter at your Residence through the online form supplied by SaskPower or by calling SaskPower at 1-888-SKPOWER at some point prior to the Contest period; and
- b) by signing up for a MySaskPower Account during the Contest period.

3) Method Three:

a) by signing up for the installation of a smart meter at your Residence through the online form supplied by SaskPower or by calling SaskPower at 1-888-SKPOWER, during the Contest period (signing up for a smart meter requires that you provide the full address of your Residence and a confirmation that the Residence is a detached home, and that you agree to the installation of a smart meter at your Residence on SaskPower's terms and conditions for such installation, which can be found at the following link: <u>Installing Your</u> <u>Smart Meter – What to Expect (saskpower.com)</u>); and

b) by having signed up for a MySaskPower Account at some point prior to the Contest period.

4) Method Four ("Write-in Entry")

- a) by printing your name, complete address, SaskPower account number, daytime telephone number, email address, age, and an original statement of between 50 and 100 words about how a smart meter will benefit you (your "Statement"), on a plain piece of paper and mailing your Statement in an envelope bearing sufficient postage to SaskPower at: "Smart Meter Contest", c/o SaskPower Airport Mobility Building, 2550 Sandra Schmirler Way, Regina, Saskatchewan, S4W 1B7. Write-in Entries must be postmarked by July 28, 2021 and received by 5:00 PM CST, July 31, 2021. The Contest Sponsor is not responsible for lost, late, illegible, incomplete, misdirected or postage due mail entries;
- b) you hereby grant SaskPower a non-revocable license to use your Statement, with or without your name and city/town of residence, without compensation other than your entry in the Contest, in any medium worldwide by the Contest Sponsor and/or its advertising or promotional agencies without limitation or further notification; and
- c) you hereby agree that if your Statement is not original, in whole or in part, you will indemnify and hold harmless SaskPower, its employees, directors, officers and agents, from any and all claims, demands and causes of action that may be brought by any third party arising from or in any way relating to SaskPower's use of your Statement.

For clarity, to enter by Method One, Method Two or Method Three, an eligible person must, by the end of the Contest period, have *both* signed up for a MySaskPower account *and* signed up for a smart meter (by the methods stated above). Entry by Method One, Method Two or Method Three is automatic upon having completed the both entry requirements by the end of the Contest period.

- 6. Only one (1) Contest entry per person is allowed, regardless of method of entry. In the event it is discovered you attempted to enter more than once, all of your entries will be void.
- 7. All submissions to the Contest (other than submissions via Write-in Entry) will be screened to confirm housing status and eliminate entries that do not meet the Residence eligibility criteria (as stated in section 3). All submissions to the Contest via Write-in Entry will be screened to confirm that the entrant has provided their valid SaskPower customer account number and the other required information, including the Statement. Any submission that does not meet the entry requirements will be void.
- 8. The Contest Sponsor is not responsible for entries that are incomplete, illegible, inaudible, damaged, irregular, have been submitted through illicit means, or do not conform to or satisfy any condition of these Contest Rules and all such entries may be disqualified. All entries become the sole property of the Contest Sponsor and none will be returned.

Prize

- 9. There is one (1) Contest prize to be won during the Contest Period, consisting of an Apple MacBook Pro (the "Prize"), with an approximate retail value of \$1,500.
- 10. Prize must be accepted as awarded. Prize may not be sold, transferred or otherwise assigned and is not convertible or redeemable to cash or other prizes. The Contest Sponsor reserves the right to substitute a Prize in whole or in part in the event that all or any component of the Prize is unavailable. Prize winner is solely responsible for all costs not expressly described herein.

11. The chance of being selected in a draw is dependent on the number of eligible entries received.

The Draw

- 12. On August 5, 2021, at Regina, SK, a random draw will be conducted from all entries eligible for the Contest to select a potential winner of a Prize (the "Draw").
- 13. The selected entrant will be notified by their email address associated with their MySaskPower account (or, if the selected entrant entered the Contest using the Write-in Entry, by the contact information provided in their entry). The Contest Sponsor assumes no responsibility for any inaccurate or incorrect information provided to it, or that results in any way from the transmission, receipt or processing of entries. If the first selected entrant does not respond within seven (7) days of this contact, the Contest Sponsor will have the right to disqualify that entrant and to randomly draw another eligible entry. By entering the Contest, you agree that if you are a selected entrant that is disqualified and a Prize is forfeited for any reason, the Contest Sponsor is fully and completely released and discharged from any liability or responsibility in this regard. The Contest Sponsor is not responsible for the failure for any reason whatsoever of a selected entrant to receive a notification.
- 14. Following notification, a selected entrant must, unaided, correctly answer a time-limited mathematical skill-testing question. In the event that a selected entrant is unable to answer the skill-testing question correctly or in the time period required, the Contest Sponsor will have the right to disqualify said entrant and to randomly draw another eligible entry, and the Contest Sponsor shall be fully and completely released and discharged from any liability or responsibility in this regard.
- 15. In order to be declared a winner, each selected entrant must also sign and return the following to the Contest Sponsor within fourteen (14) days of provision of the same from the Contest Sponsor:
 - a) A form affirming eligibility and compliance with all Contest Rules (form may require notarization);
 - b) A liability release form releasing the Contest Sponsor, its directors, employees, officers, agents and affiliates from all liability arising from or relating to the acceptance, receipt, possession, use or misuse of an awarded Prize, participation in this Contest and/or in any Contest-related activity;

16. If a selected entrant is not eligible or does not otherwise meet the requirements as set out in the Contest Rules, the Contest Sponsor will have the right to disqualify said entrant and randomly draw another eligible entry for purposes of awarding a Prize, and the Contest Sponsor shall be fully and completely released and discharged from any liability or responsibility in this regard.

General Conditions

17. By entering the Contest, entrants agree to release and indemnify and hold harmless the Contest Sponsor and its directors, employees, officers, servants, agents and affiliates from any injury, loss or damage of any kind to persons or property, including but not limited to death, resulting in whole or in

part directly or indirectly from the acceptance, receipt, possession, use or misuse of an awarded Prize, participation in the Contest and/or in any Contest-related activity.

- 18. No Prize claim may be completed after the period of six (6) months from the date of the Draw. An unclaimed Prize will not be awarded.
- 19. The Contest Sponsor reserves the right, in its sole discretion, to terminate, modify or suspend the Contest, or modify the Contest Rules at any time for any reason whatsoever.
- 20. All draws will adhere to the draw procedures established for the draw by the Contest Sponsor The Contest Sponsor will not be liable for any human or technical errors that may arise or occur in connection with the Contest. The Contest Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of the entries.
- 21. The Contest Sponsor will not be liable for any human or technical errors that may arise or occur in connection with the Contest. The Contest Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of the entries.
- 22. No correspondence will be entered into with entrants except with entrants selected as a potential winner of the Prize.
- 23. The Contest Sponsor is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, failure of any e-mail or entry to be received by the Contest Sponsor as a result of technical problems or human error, or any combination thereof, other failed entry attempts or other errors for any reason whatsoever.
- 24. The Contest Sponsor reserves the right at its sole discretion to disqualify any individual who tampers with or attempts to tamper with the entry process or the operation of this Contest or who acts in violation of these Contest Rules or otherwise in a disruptive manner. ANY ATTEMPT BY AN ENTRANT TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE CONTEST SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH ENTRANT TO THE FULLEST EXTENT PERMITTED BY LAW INCLUDING CRIMINAL PROSECUTION.
- 25. This Contest is governed by the laws of Saskatchewan and the laws of Canada applicable therein, and is subject to all applicable federal, provincial and municipal laws and regulations.
- 26. By entering this Contest, the entrant agrees that the courts of the Province of Saskatchewan, Canada shall have jurisdiction to entertain any action or other legal proceedings based on any provision of the Contest Rules or the running of this Contest. The entrant hereby irrevocably attorns to the exclusive jurisdiction of the courts of the Province of Saskatchewan.
- 27. THE CONTEST SPONSOR IS COLLECTING PERSONAL INFORMATION ABOUT ENTRANTS FOR THE SOLE PURPOSE OF ADMINISTERING THIS CONTEST (UNLESS OTHERWISE PROVIDED FOR BY THE CONTEST RULES) AND BY PROVIDING SUCH PERSONAL INFORMATION A PARTICIPANT IS CONSENTING TO SUCH COLLECTION, USE AND DISCLOSURE OF THE SAME FOR SUCH PURPOSE. The Contest Sponsor will not sell or transmit this information to third parties except for the purposes of administering this Contest (unless otherwise provided for by the Contest Rules or agreed to by the Participant).
