**HOME/FARM OWNER
ELECTRICAL WIRING PERMIT**
Permit valid for 12 months from date of purchase

To be eligible for an *Electrical Wiring Permit*, you must agree with the following:

- I am the owner and occupant of the property.
- I am **not** preparing the premises for sale or rent.
- I have not held a permit for the complete wiring of a residence in the last 12 months.
- I agree to perform all the work to the requirements of the current *Canadian Electrical Code* and *Saskatchewan Interpretations*.
- I agree to make arrangements for all required inspections of the work done under this permit.
- I accept full responsibility for the safety and proper functioning of the installation and acknowledge that any defects found by an inspector will require correction before the wiring is granted final approval.
- I understand that a single family dwelling means a detached house that is intended for the use of one family.
- I understand that it is unlawful for any person outside the permit holder's immediate family to undertake any part of the work of the installation to which this permit applies.
- I understand that this application is restricted to a single phase non-hazardous electrical installation not exceeding 200 amps or 300 volts between phase conductors. Electrical work exceeding 200 amps or 300 volts, polyphase or in hazardous locations must be performed by a licensed Saskatchewan electrical contractor.

1. **Electrical Service – Home/Farm**

Owners must be installed by a licensed Saskatchewan electrical journeyperson **OR** an immediate family member who is a licensed Saskatchewan electrical journeyperson and is installing the service. Immediate family is defined as: father, mother, father-in-law, mother-in-law, spouse, brother, sister, son, daughter, brother-in-law, sister-in-law, son-in-law, daughter-in-law, grandparent, grandparent-in-law, common-law spouse.

2. **A hot tub, swimming pool or Generlink**

must be wired by the applicant who is a licensed Saskatchewan electrical journeyperson **OR** an immediate family member who is a licensed Saskatchewan electrical journeyperson.

3. **Addition of a Sub-Panel** - example -

installing an electrical panel in your house or garage fed from the main panel in your house.

4. **Single family dwelling with or without an attached garage - branch circuit wiring**. This fee of \$400.00 is for a single family dwelling 200 amps or less.

5. **Wiring of a farm outbuilding - branch circuit wiring**. This fee of \$150.00 is for each farm outbuilding 200 amps or less.

6. **For renovations to a residential building - branch circuit wiring only** (ex. kitchen renovation). As long as the work being performed is not more than 50% of the residence being wired or rewired, it is a fee of \$150.00 per floor.

7. **Residential garage (wiring or rewiring) - branch circuit wiring only**.

8. **Equipment Wiring** - this is for "hard wired" equipment only. This would include electric heaters, furnaces, air conditioners, etc. This option is not required with items 4, 5, 6, and 7.

9. **Addition or Replacement of lights, switches, outlets or smoke detectors**.

List how many of each will be added. If the total amount of the items exceeds the \$150.00 fee, do not use this section. Complete item #6 on the application form.
